Investment Objective

Menhaden PLC (the "Company") seeks to generate long-term shareholder returns, predominantly in the form of capital growth, by investing in businesses and opportunities that are demonstrably delivering or benefiting significantly, from the efficient use of energy and resources, irrespective of their size, location or stage of development. To reflect its non-benchmarked total return investment strategy, the Company uses RPI+3% as its primary long term financial performance comparator. In addition to this absolute return performance measure, the Company also uses a range of specialist, sectoral and peer group benchmarks to assess its relative performance.

Commentary

During April, the Company's net asset value ('NAV') per share was up 5.5%, the share price was up 1.7%, while the RPI+3% was up 0.6%.

Our public equities portfolio rose over the month and added 6.0% to our NAV. Alphabet and Charter Communications delivered positive performance, adding 3.1% and 1.6% respectively to our NAV. Both companies reported good quarterly results, with Alphabet delivering exceptional revenue growth on a year-over-year basis and Charter further increasing penetration across its footprint, with the addition of 355k internet subscribers.

The share prices of our aerospace duo, **Airbus** and **Safran**, have recovered significantly from their lows last year, with Safran adding a further 0.9% to our NAV during the month. We opted to take some profits and chose to fully exit our position in Airbus and to reduce our position in Safran by 1% of NAV. Since our original investment in Airbus in May 2016, we have generated an IRR of 28%.

We also received cash proceeds of £6.1m following the completion of the sale of Calisen. This transaction represented a return on investment of approximately 1.8x over four years, equivalent to a net IRR of 15%.

We redeployed part of these proceeds by materially adding to our position in **Microsoft**. This holding now equates to approximately 8% of NAV. Microsoft's products are ubiquitous and the pace of digital transformation is only accelerating. We remain optimistic on the company's prospects.

Following **Canadian Pacific's** bid in March, **Canadian National** made a competing offer to acquire Kansas City Southern. Whilst Canadian National's bid is more than 20% above Canadian Pacific's offer, we believe the deal will likely still work from a financial standpoint. Either company will need to obtain regulatory approval in order to complete its respective bid. We decided to incrementally add to our position in Canadian Pacific during the month.

Investment Policy

The Company's investment objective is pursued through constructing a convictiondriven portfolio consisting primarily of direct listed and unlisted holdings across different asset classes and geographies. The Company invests, either directly or through external funds, in a portfolio that is comprised of three main allocations: listed equity; yield assets; and special situations. The flexibility to invest across asset classes affords the Company two main benefits: 1) It enables construction of a portfolio based on an assessment of market cycles; and 2) It enables investment in all opportunities which benefit from the investment theme. It is expected the portfolio will comprise approximately 15 to 30 positions.

The portfolio will be predominantly focused on investments in developed markets, though if opportunities that present an attractive risk and reward profile are available in emerging markets then these may also be pursued. While many of the companies forming the portfolio are headquartered in the UK, USA or Europe, it should be noted that many of those companies are global in nature so their reporting currency may not reflect their actual geographic or currency exposures. Subject to any applicable investment restrictions contained in the Listing Rules from time to time, the Company will not make an investment if it would cause a breach of any of the following limits at the point of investment: 1) no more than 20% of the Company's gross assets may be invested, directly or indirectly through external funds, in the securities of any single entity; and, 2) no more than 20% of the Company's gross assets may be invested in a single external fund.

Finally, we initiated a new position in French infrastructure group, **VINCI**. The company has a strong track record of building and operating critical infrastructure assets around the world and is currently transforming its business, with the aim of achieving a 40% reduction in carbon emissions by 2030. Last year the group successfully raised its inaugural green bond and the recently announced deal to acquire ACS' Energy business provides it with a best in class renewable energy development platform. We deployed approximately 2% of our NAV.
